Open Door Mission's DoorWay Drug and Alcohol Recovery Program employs a multi-level treatment approach to drug and alcohol recovery. It's an intensive, 7 to 13-month, Christ-centered program designed to help students overcome drug and alcohol addictions. When men enter the program, they are involved in a comprehensive curriculum of 12-Step programming, self-discovery, life-skills, and spiritual renewal, Bible study and employment. They also participate actively in mentoring, counseling, and 12-step work. During 2014 The organization served over 100 men per day.

The Jack Mayfield House Transitional Living Program provides up to 6 months of housing, food, clothing, education and health care for men who have graduated from the DoorWay Drug/Alcohol Recovery Program. The men who qualify for this aftercare housing must be graduates of the DoorWay Program and employed. These men have available to them food, shelter, clothing, and access to social services for this period of time. These men continue recovery group participation, counseling and an opportunity to help men still in the recovery program. The men living in this house pay rent of \$100 per week to the Mission. During 2014, the organization served up to 20 men per day.

The Open Door Mission's (ODM) Russell M. Scott Jr., M.D., Convalescent Care Center (RMSCCC) provides homeless men a safe, short-term environment to continue their convalescence from surgery, injury or illness. Frequently, homeless persons are discharged from hospitals with care instructions that are difficult to follow while living on the streets. Homelessness exacerbates health problems, complicates treatment and disrupts continuity of care. Homeless persons are 3 to 4 times more likely to die prematurely than are their housed counterparts. These deaths are most often associated with acute and chronic medical conditions - which are exacerbated by life on the streets or in traditional shelter environments. The RMSCCC provides medical respite services to homeless men. Medical respite is a term used to describe recuperative or convalescent services needed by homeless people with medical problems. This service offers an alternative to discharging patients to the streets and allows for continuation of hospital-recommended care.

During 2014, the organization served up to 25 men per day. Men may reside in this Center for a period of a few days to over a year.

The Education and Technology Center is available to all men at the Mission as well as community men and women seeking a GED. This service is available at no cost to either the residents or community participants. All men in the DoorWay Program must attend the education program whether they have a high school diploma or GED prior to coming into the program. Knowledge is power and education is a requirement.

The Board of Directors is provided a copy of the Form 990 for review prior to it being filed.

Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts

Directors are advised of any transaction that could result in a conflict of interest. If transactions for a specific service are required for operations, then bids are obtained and analyzed. All Directors except those with a conflict will discuss and evaluate the bid and vote to accept or reject it.

Form 990, Part VI, Line 15a - Compensation Review & Approval Process - CEO & Top Management

The executive committee reviews surveys on compensation provided by national and local sources. The compensation decisions are based on the surveys, performance reports and the budget.
